## Motor Control Technician

The position we are accepting applications for is Motor Control Technician. The motor control technician will work in the field and our shop troubleshooting, installing, upgrading, assembling, testing and starting up motor control systems. These systems usually operate pumping equipment generally sewage life stations. A sewage lift station is made up of pumps, piping, valves, control system, access covers as well as other accessories. The type of equipment includes basic relay controls, programmable logic controllers, variable frequency drives, dialers, SCADA system equipment.

The motor control technician will work in the field sometimes alone out of a van or pick-up and sometimes with a helper in a larger crane equipped service truck. All safety equipment and specialized tools are provided but it is expected that the technician will provide his own basic tools.

The Motor Control Technician, like all our employees, does not have a limited job description but is expected to do the work required to meet our customer's needs including working overtime.

A rotating group of service employees carry cell phones and stand by to work in order that we may give our customer's 24-hour service. These employees are compensated for this and all drivers, mechanics and technicians take turns being on standby for one-week period at a time.

All applicants should have a valid driver's license in their state of residency and a clean driving record.

Other essential job tasks include:

1. Accurate completion of paperwork so that it is filled out in a way that the customer and we can understand.
2. Understand and work with 3 phase electric power.

3. Must be familiar with the operation of motor controls and understand the basic components such as starters, relays, heaters etc.
4. Must be able to read wiring diagrams and schematics.
5. Must be familiar with the operation of both single and three phase motor controls
6. Must understand relay logic
7. Must understand analog signals
8. Should have experience with Programmable Logic Controllers
9. Should have experience with Variable Frequency Drives
10. Good reading skills in order to understand equipment manuals.
11. Good interpersonal skills with ability to deal effectively with customers and coworkers.
